System Process Description

Raw Source

The distribution system receives treated water from the Township of Severn's Washago Water Treatment Plant (DWS No. 220005161) which receives its raw water from Lake Couchiching. The Township of Severn's Washago Water Treatment Plant is a Large Municipal Residential drinking water system that provides disinfection with sodium hypochlorite, coagulation and flocculation with alum and a cationic polymer and multimedia filtration.

Distribution System

The distribution system consists of approximately 700m of 50mm diameter watermain, including a watermain that conveys treated water across the Severn River. There are three sample stations installed in the distribution system and one blow-off.

Flows

Treated Water Flows

Daily water use is monitored by a magnetic flow meter owned and operated by the Township of Severn. Flow meter readings are collected by operations staff throughout the year to monitor water consumption. Based on the readings collected in 2022 the estimated average daily flow is: 6.06 m³/day. The estimated total annual flows for 2022 is: 2222.22 m³. Based on 20 connected lots, with an estimated population of 52 residents (based on the average population of 2.6 people per dwelling). The estimated per capita average water consumption is: 117L/p/day.

Note: The flow meter did not allow reads to occur from approximately September 29, 2022-January 13, 2023. During this time, the daily flows were averaged using the meter read in January 2023.

Note: There was a leak in August, which showed higher water usage until it was located and repaired.
