- Use the roll number on the bill for your tax account.
- Payments take 2-5 business days to reach the township.

The approved 2024 budget reflects the reinvestment into core infrastructure and the strategic planning of future roads and recreation, with 18.4 million allocated to capital projects.


#### 2024 Capital Projects


