# Council - February 8, 2021

### **MAYOR UPDATE**

Mayor Clarke opened up the meeting and reported that Brock Township lost their Mayor, Debbie Bath-Hadden, to cancer on January 24th, 2021. Basil sends his condolences and deepest sympathies to her family and friends and all those at Brock Township. Debbie Bath-Hadden was elected in 2018 and was the first female Mayor in Brock Township and was a strong community advocate and volunteer for her community. Basil also reported that himself, CAO John Pinsent, Planning Supervisor/Zoning Administrator Deb McCabe and Planning Technician Eric Brathwaite met with the City of Orillia Council to discuss the Rama Road Corridor and to clarify some questions and issues raised. ### **CAO UPDATE**

CAO, John Pinsent, reported that at this time the Township has started to expand internet services in Ramara, but understands that there is still need for improvement. ### **INTERNET**

Grant Street from Canadian Internet Registration Authority (CIRA) presented to Council on their initiative to build a better online Canada by offering high quality internet tests that is focused on speed. CIRA collects information about individuals and businesses on their internet upload and download speed, jitter, latency, packet loss, test date and time. Grant reported that 896,000 Canadian tests have been done through the site with more than 850 municipalities using the data and mapping. Council approved that a report be brought back to Committee of the Whole on the SWIFT and CIRA surveys. This report will build out the information required to decide as to how to support an expansion of internet services in the Township of Ramara.

## **GUN (SHOOTING) RANGE - COUNTY OF SIMCOE SUPPORT**

Mayor Basil Clarke reported that the County of Simcoe approved the Township of Ramara Official Plan Amendment No.19 Gun (shooting) clubs and/or firearm shooting ranges. The Official Plan Amendment is now in the appeal period which ends on February 22, 2021. The purpose and effect of the amendment is to establish planning policies and definitions within the Township Official Plan to regulate the use of land for gun (shooting) clubs and/or firearm shooting ranges throughout the Township.

## RATIONALE FOR LAKE SIMCOE PROTECTION PLAN (LSPP)

A report came to Council as a follow up from the Committee of the Whole meeting on February 1st, in order to get a clear understanding on next steps with the LSPP and Bayshore Village Sewage Treatment Plant. The Province of Ontario has initiated a 10-year review of the LSPP and staff and Council will be providing comments to the Ministry and ask the Ministry to recognize the Bayshore Village Sewage Treatment Plant as an existing municipal sewage treatment plant. However, as the Township is uncertain of the Province's decision, staff are looking for direction on the short, medium and long-term initiatives. Given the current status of the lagoons and the land associated with spray irrigation, the following is recommended as part of the ongoing desire to replace the current system:

- Resolve the Infiltration & Inflow problem; and
- Establish a time frame and costs associated with a Class EA Schedule B (addition to the spray fields) vs Schedule C (upgrade to a mechanical plant).
