

COUNCIL HIGHLIGHTS

Council - February 22, 2021

MAYOR UPDATE

Mayor Clarke opened the meeting and advised that Council received many questions and concerns regarding the deputation on the Rama Regional Airport. The Mayor advised that there has been no decision made on this issue and that the first step was for the applicant to make a public deputation to Council requesting the purchase. The next step, based on the motion at Council, would be for staff to prepare a report. If staff advises that there is no future use for the land, then the Township would follow Bylaw 2005.114 "A Bylaw to establish procedures governing the sale of land.' Residents will have an opportunity to provide their comments through the process or by making a deputation at a Council meeting. WARD BOUNDARY REVIEW

John Matheson and Olivia Lahaie from Strategy Corp presented on the Interim Report for the Ward Boundary Review. From January 11th to February 1st, Strategy Corp conducted their Phase 1 of Public Consultations. From the comments they received from Council, staff and residents, Strategy Corp created an Interim Report. From the report, Strategy Corp found that the current ward structure no longer delivers effective representation due to the inequalities of population among wards. As well, it was reported that inequalities of population is forecast to worsen over the period of 2020-2030.

The next steps are for Strategy Corp to develop ward boundary concepts, conduct Phase 2 of Public Consultations and submit a final report to Council.

WELL DONE RAMARA LIBRARY STAFF

Council received a letter from a resident thanking the Ramara Township Public Library staff for their hard work and diligence through the pandemic. Staff, even through the pandemic, were able to provide access to reading and learning materials and virtual programs and events.
