WELCOME NEW STAFF!!

Committee welcomed Tanya Budgen, our new Recreation & Community Services Supervisor, and Amanda Mason, our new Bylaw Enforcement Officer, to the Township of Ramara.

LAGOON CITY PARKS AND WATERWAYS LEVY BYLAW

Committee approved, in principle, the proposed amendment to Bylaw 2001.87 to increase the base levy of Short Term Rental Accommodation units in Lagoon City to the same as hotels/motels. Once the bylaw is red at the first and second time by Council, it will be sent to the Ontario Land Tribunal for approval. Once approved by the Ontario Land Tribunal, it will then be presented to Council for a third reading.

GORING CROSSING - OAKLAND BEACH SUBDIVISION

Committee approved to proceed with collecting fees related to Goring Crossing repairs, but allow for a \$3000 grant(exact amount to be determined) to be obtained from each of the homeowners and developer. At this time, \$80,000 from homeowners and \$60,000 from the developer remains to be collected.

METHOD OF VOTING FOR THE 2022 MUNICIPAL ELECTION

Committee approved for the 2022 municipal election to have the following voting options:

- 1. Internet/Telephone voting and
- 2. Paper ballot election with tabulators for three advance voting days.

For internet/telephone voting, residents will receive a letter containing instructions on accessing and completing their vote via telephone or the internet. Voters who require assistance or do not have the means to connect by internet or phone can access a help desk at the Administration Building or the Ramara Public Library. The advance voting by paper ballot will allow citizens to vote in person and cast a physical ballot on one of three advanced voting days.

GOOD DOCTORS UPDATE

Committee approved to ask the Good Doctors to join Council at the September 27, 2021, Council meeting to get all questions and concerns addressed before entering into an agreement.

MOTORIZED VEHICLES ON MUNICIPAL PROPERTIES

Committee approved to update Bylaw 1995.36 to prohibit Motorized and Electric Vehicles on Municipal Properties including the private beaches in Lagoon City. These vehicles will include golf carts and electric bikes. Please note that the bylaw will not prohibit any accessible mobility devices.

MOORING BOATS IN LAGOON CITY CANALS

At the August 12, 2021 Lagoon City Parks and Waterways Commission meeting, it was reported that some residents were parking perpendicular to the Shorewall or rafting multiple boats together. As a result of these actions, it has created a narrower passage throughout the canals, which can cause difficulty for those navigating. A report was brought to Committee to consider a new draft Balyw to regulate the mooring of boats in the canals. After some discussion, Committee brought some options forward, including implementing a permitting system that will come back to a future Committee meeting.

COMMUNITY BUILDING FUND - CAPITAL STREAM

Committee approved to apply for the Community Building Fund - Capital Stream, to replace the playground equipment at both Bluebird Park and Lagoon City Beach and Park. The Township will ask for \$300,000 to put towards the reconstruction of both of these playgrounds.

UPDATE ON ZONING BYLAW AMENDMENT

Darryl Tighe of D.M Wills Associates Limited presented a report to Committee regarding the proposed Zoning By-law Amendment for 2498 Concession Road 3. The Zoning Bylaw Amendment, which is required for conformity with the Official Plan Amendment, which is currently with the County of Simcoe for adoption, will be brought forward for consideration and adoption on September 27, 2021. The Official Plan Amendment, was adopted by Council on July 12, 2021 and now at the County of Simcoe for approval, proposes changing the subject property's designation from 'Agriculture' to 'Agriculture Special Policy, ' which will allow a secondary dwelling to be located on the subject property.

SEPTIC RE-INSPECTION PROGRAM

Walied Zekry, Chief Building Official, reported that the mandatory and discretionary septic re-inspection program would commence this fall. The mandatory sewage Re-Inspection program asses 82 septic systems and is mandated through the Ontario Building Code with **Ontario Regulation 315/10**. This amendment helps protect Ontario's drinking water and the natural environment and supports implementing the **Clean Water Act, 2006 (CWA)** and the **Lake Simcoe Protection Act**. The Township of Ramara established the Discretionary Sewage Re-Inspection program through Bylaw 2019.73 to meet provincially mandated requirements. 528 out of roughly 2500 discretionary septic systems in Ramara will be looked at over the next five years. Residents can visit our **website** to see the **list of mandatory and discretionary sewage systems** that will be investigated this year.

SIMCOE COUNTY NEW CART PROGRAM
