The Commission approved for a new Chair to be appointed at the January 12, 2023 meeting when all members of the Commission were present at the meeting. A new member of the L.C.P.W.C. meeting will be appointed at the December 12, 2022, Council meeting.

2022 DREDGING TENDER OPENING COMMITTEE REPORT AND ENGINEERING TENDER REPORT

The Tender Opening Committee commenced on December 1, 2022, at 2:00 p.m. and opened all received tenders for the L.C.P.W.C. 2022-2023 Canal Dredging. With all four tenders received, each included all necessary documents and were evaluated by Tatham Engineering as follows:

- Galcon Marine Ltd. with a bid price of \$327,403.50
- QM LP dba QM Environmental a bid price of \$1,360,516.00
- Envision Excavating Ltd. with a bid price of \$950,000.00
- Robinson Haulage Inc. with a bid price of \$710,575.00

The dredging work will be conducted in the following areas: Gondola Lagoon, Mews Back Lagoon and Cedar Lagoon. Tatham Engineering recommends Galcon Marine Ltd. for their experience and competitive price. The work is scheduled to start in fall 2023 with a tentative start work date of November 4, 2023. The Commission approved the award of the Dredging Contact to Galcon Marine Ltd. in the amount of \$327,403.50 and that Tatham Engineering will acquire the required permits.

2023 MEETING SCHEDULE

The Committee approved the 2023 meeting schedule; the Commission will continue to meet on the second Thursday of each month starting at 9:30 a.m. in the Council Chambers. The meeting will be live streamed and broadcast on the Township of Ramara's [YouTube channel](#).

NOISE FROM BEAVER TRAIL CLEAN FLO™ HOUSE

The Committee approved for staff to investigate the noise emitting from the Beaver Trail Clean Flo™ House in consultation with WeedsBGone. Commissioner Bell reminded residents to use the online Report a Concern form to address matters in order for staff to allocate the necessary resources and time to resolve issues.

INFRASTRUCTURE UPDATES

The Infrastructure department provided the following updates to the Commission:

- The Cedars at the take-off area have been inspected and will be replaced in the spring by the contractor.
- The Beaver trail system diffusers project is complete.
- The harvester and barge are wrapped and stored at the Work Yard in Brechin at no charge to the Commission.
- The new harvester equipment is still estimated for a July 2023 delivery date.
- The gates at the Pier One resort will remain open during the winter months south.
- The Commission will further discuss the wooden beach sign in early 2023.
